By subtracting shapes strategically, the final logo achieves a sense of depth and dimensionality, adding visual interest and intrigue to the design.










BLACK & WHITE

COLORED BACKGROUND


When you are applying the logo type to a colored background it needs to be high contrasting. No additional effects such as stroke or dropshadow are requried.


